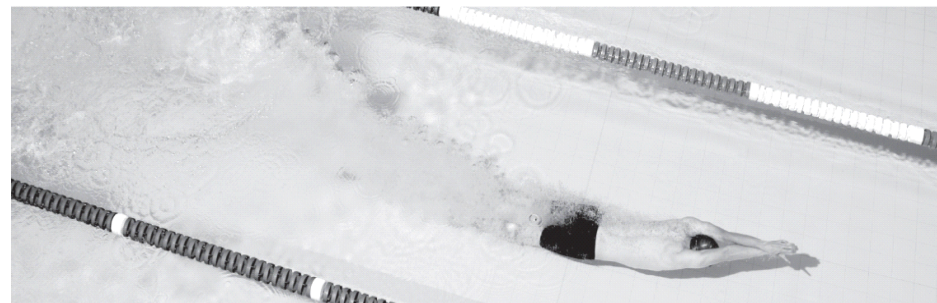

Membership Terms and Conditions

1. Your membership card must be shown prior to obtaining an activity or facility ticket. Tickets must then be displayed at the activity or facility.
2. On commencing your membership, all fees together with any pro-rata payments must be made at the time of joining.
3. For payable activities, members may book 10 days in advance, non members may book 7 days in advance.
4. Failure to give one clear days notice for cancellation of book-able activities will result in full payment being required.
5. Regular replacement of a lost Membership or Induction cards will regretfully incur the a £2.50 fee to replace it. No entry will be permitted without the production of a valid membership card.
6. Memberships and/or cards are not transferable.
7. The non-payment of a direct debit will render your membership as invalid until such payments have been made.
8. No Refunds given on Memberships.
9. Annual Memberships - these will run for a period of 12 months from the date of commencement. Regrettably no refunds can be given if you terminate your membership before the expiry date.
10. All normal rules and regulations of the Centre apply at all times.
